FOR FRANK MERLINO, DOING BUSINESS AS TRU GREEN**


WHEREAS, Frank Merlino (applicant), has applied for a Direct Sellers Permit for doing business as Tru Green, a residential lawn care services; and


WHEREAS, the applicant has complied with the Windsor Direct Seller Permit Ordinance;







- A driver's license or some other proof of identity as may be reasonably required.
- A state certificate of examination and approval from the sealer or weights and measures where applicant's business requires use of weighing and measuring devices approved by state authorities.
- A state health officer's certificate where applicant's business involves the handling of food or clothing and is required to be certified under state law; such certificate to state that applicant is apparently free from any contagious or infectious disease, dated not more than ninety (90) days prior to the date of application for license is made.
- If employed by a charitable organization, present complete copy of registration materials and annual report.
- Every applicant for a license who is not a resident of the County, or who is such a resident and represents businesses or organizations whose principal place of business is located outside of the state of Wisconsin, shall file with the Town Clerk a surety bond for a term of one (1) year from the date of issuance of the license, running to the Town in the amount of \$5,000 with surety acceptable to the Town Business Manager.



