

**VILLAGE OF WINDSOR
BOARD RESOLUTION 2016-76**

**APPROVAL OF ESTABLISHING A POLLING LOCATION FOR
WARDS 6, 7, 8, 9 AND 10 OF THE VILLAGE OF WINDSOR**

WHEREAS, the Windsor Municipal Building, located at 4084 Mueller Rd., DeForest, is the polling location for all Wards (1-10) of the Village of Windsor as shown on Exhibit A; and

WHEREAS, the Windsor Municipal Building does not have the capacity to accommodate all Wards due to the growth in the community; and

WHEREAS, the Windsor Municipal Building can accommodate Wards 1, 2, 3, 4 and 5; and

WHEREAS, the electors would be better served with two poll locations; and

WHEREAS, pursuant to Section 5.25(3) of Wis. Stats polling places shall be established for each election at least thirty (30) days before the election; and

WHEREAS, there is no additional public building to accommodate a poll location; and

WHEREAS, Wis. Stat. 5.25(1) allows for the use of a nonpublic building that better serves the needs of the electorate; and

WHEREAS, the Lake Windsor Country Club, 4628 Golf Road, Windsor, has graciously offered their facility to serve as a poll location;


WHEREAS, the Village Board has reviewed the relevant information,

NOW THEREFORE, BE IT RESOLVED, by the Village Board of the Village of Windsor that it hereby approves the establishment Lake Windsor Country Club as the poll location for Wards 6, 7, 8, 9 and 10 beginning with the August 9th, 2016 Partisan Primary and all future elections.


BE IT FURTHER RESOLVED, that the Village Clerk is directed to notify registered voters of the above named wards.
