WHEREAS, Linda L. Schultz, (applicant), has applied for a Fireworks Sales Permit doing business as Uncle Buck's Fireworks, LLC, to sell fireworks at 4508 Lake Circle, Windsor; and

WHEREAS, applicant has complied with Windsor Code of Ordinances, Chapter 24 – Fire Prevention and Protection, Article IV. – Fireworks, Division 2. Sale, Storage and Discharge of Fireworks Restricted with the exception of the 45 day advance submittal requirement; and

WHEREAS, the Village Clerk recommends waiver of the 45 day submittal requirement due to proper submittal of materials and sufficient review time, and the Village Board concurs;


NOW THEREFORE, IT IS HEREBY RESOLVED, by the Village Board of the Village of Windsor, as follows:

The Fireworks Sales Permit for Linda L. Schultz, doing business as Uncle Buck's Fireworks, LLC, from June, 12, 2016 through July 07, 2016 and at the location and times set forth on the application, is hereby approved subject to the following conditions:

1. Final inspection and approval from the DeForest Area Fire and EMS Inspector. Applicant shall make arrangements for inspection with the Inspector or this approval shall be deemed null and void. The Inspector shall provide written confirmation of approval to the Village.


