

**VILLAGE OF WINDSOR
BOARD RESOLUTION 2019-26**

**APPROVAL OF AN AMENDMENT TO THE VILLAGE OF WINDSOR'S
BOUNDARY AGREEMENT WITH THE TOWN OF VIENNA
PURSUANT TO SEC. 66.0301(6), WIS. STATS.**

WHEREAS, Wis Stat. §66.0301 authorizes municipalities to enter into intergovernmental agreements for various purposes, including the establishment and adjustment of the boundary lines between them; and

WHEREAS, the Village of Windsor ("Village") and the Town of Vienna ("Town") negotiated and entered an intergovernmental agreement, which was adopted by the Village on April 14, 2016 ("2016 Vienna-Windsor Agreement"), a copy of which is attached as Exhibit A and incorporated by reference; and

WHEREAS, the governing bodies desire to amend the boundary lines established in the 2016 Vienna-Windsor Agreement, while continuing to provide for mutually agreed upon extraterritorial jurisdictional and planning areas as well as mutually agreed upon timelines for further discussion, renewal and termination, all as set forth in the proposed amendment to the 2016 Vienna-Windsor Agreement ("2019 Amendment"), a copy of which is attached hereto as Exhibit B and incorporated by reference; and

WHEREAS, a public hearing on the terms of the proposed 2019 Amendment was held on April 18, 2019, after due notice as required by Wis. Stat. §66.0301(6)(c)1, to solicit public input on the terms of the proposed amendment; and


WHEREAS, the Village Board finds that the terms of the proposed amendment to the 2016 Vienna-Windsor Agreement are reasonable, and the approval of the amendment will promote orderly development within the affected communities, minimize future intergovernmental conflicts and reasonably protect the economic interests of the Village;

NOW, THEREFORE, IT IS HEREBY RESOLVED, that the Village Board approves the amendment to the 2016 Vienna-Windsor Agreement attached hereto as Exhibit B, and the Village President and Clerk are hereby authorized to execute the agreement on behalf of the Village upon approval of the same amendment by the Town of Vienna.



**FIRST AMENDMENT TO
BOUNDARY AGREEMENT BETWEEN
VILLAGE OF WINDSOR AND
TOWN OF VIENNA**

THIS FIRST AMENDMENT TO BOUNDARY AGREEMENT BETWEEN THE VILLAGE OF WINDSOR AND THE TOWN OF VIENNA (“**Amendment**” or “**Amendment to Vienna-Windsor Agreement**”) is made and entered into between the VILLAGE OF WINDSOR, a Wisconsin municipal corporation located in Dane County, Wisconsin, with the powers and privileges of a municipal corporation at common law and conferred by ch. 61 of the Wisconsin Statutes (“**WINDSOR**”), and the TOWN OF VIENNA, a body corporate and politic located in Dane County, Wisconsin, with those powers granted by law and conferred by ch. 60 and ch. 61 of the Wisconsin Statutes (“**VIENNA**”). WINDSOR and VIENNA are collectively referred to herein as the “**Parties**,” and either may be individually referred to as “**Party**.” The Agreement shall be effective when approved and fully executed by the Parties.

RECITALS

WHEREAS, in 2016, WINDSOR and VIENNA entered into a boundary agreement (the “**Vienna-Windsor Agreement**”) as authorized under §66.0301 of the Wisconsin Statutes to enter into agreements for the exercise of governmental functions on a cooperative basis and §66.0301(6) of the Wisconsin Statutes to make agreements regarding the maintenance of certain boundaries as well as provisions for boundary changes; and

WHEREAS, the Parties wish to amend the Vienna-Windsor Boundary Agreement so that it reflects boundary changes that have occurred between the Town of Vienna and the Village of DeForest subsequent to approval of the Vienna-Windsor Boundary Agreement, all in accordance with the terms set forth herein.

AGREEMENT

NOW, THEREFORE, in consideration of the above recitals, which are incorporated herein by reference, and other good and valuable consideration, the sufficiency of which is hereby acknowledged, WINDSOR and VIENNA agree as follows:

ARTICLE I
ADJUSTMENT TO EXTRATERRITORIAL JURISDICTION:
ELIMINATE WINDSOR ETJ AREA SOUTH

The boundary adjustment being made by this Amendment relates solely to the area marked as “Windsor ETJ Area South” on the map attached as Addendum A to the Vienna-Windsor Agreement adopted in 2016. Windsor ETJ Area South is eliminated by this Amendment.

The map attached hereto as **Addendum A** and incorporated by reference (“**2019 Windsor ETJ Map**”), eliminates Windsor ETJ Area South and continues to depict Windsor ETJ Area North which is the area in VIENNA in which WINDSOR shall continue to exercise its extraterritorial jurisdiction as to plat map and certified survey map review (“**2019 Windsor ETJ Area**”). The legal description of the 2019 Windsor ETJ Area is attached as **Exhibit One** and incorporated by reference.

All references to “Windsor ETJ Area” in the Windsor-Vienna Agreement shall be amended to refer to the 2019 Windsor ETJ Area as described in this Amendment.

ARTICLE II
NO ADJUSTMENT TO PLANNING AREA

No adjustment is being made to the Vienna-Windsor Planning Area, which is marked “Windsor Review Area” on the map attached as Addendum A to the Vienna-Windsor Agreement adopted in 2016.

ARTICLE III
RATIFICATION

Except as expressly modified by this Amendment, the Vienna-Windsor Agreement is ratified and in full force and effect. All terms used in this Amendment shall have the same meaning as in the Vienna-Windsor Agreement unless otherwise defined herein.

ARTICLE IV
EFFECTIVE DATE

This Amendment shall become effective thirty-one (31) days after publication by both WINDSOR and VIENNA of this Amendment as a class 1 notice as required by Wis. Stat. §66.0301(6)(c)1. Neither Party shall publish this Amendment unless and until both parties have done all of the following in compliance with Wis. Stat. §66.0301(6)(c):

1. Published a Class 1 notice of a public hearing of this Amendment under Wis. Stat. ch. 985, with such notice published at least twenty (20) days prior to the public hearing.
2. Held a public hearing on this Amendment in accordance with the published notice;
3. Approved this Amendment by resolution adopted by its governing body following the public hearing, all as provided in Wis. Stat. §66.0301(6)(c)1.

Notwithstanding the foregoing, if, within 30 days of the publication of this Amendment, a petition for referendum is filed in accordance with Wis. Stat. §66.0301(6)(c)2., this Amendment shall not be effective until the results of the election in favor of this Amendment are certified. In the event of a referendum whose results do not approve this Amendment, this Amendment shall be void and the Vienna-Windsor Agreement shall remain in effect as originally approved and without amendment.



