Minutes

1) Call Meeting to Order and Roll Call- The meeting was called to order at 5pm by President Blau. All members were present.

Present were: Judd Blau- Village of DeForest, Bob Wipperfurth- Village of Windsor, Don Madelung- Village of Windsor, Colleen Little- Village of DeForest, Chief LaFeber, Fill in Office Manager Molini.

- 2) Recitation of the Pledge of Allegiance- Led by Wipperfurth
- 3) Appearances Before the Board- N/A
- 4) Approve Minutes:
 - a) August 5, 2020- Motion to approve by Little, second by Madelung. Motion carried 4-0.
 - **b)** August 19, 2020- Motion to approve by Little, second by Madelung. Motion carried 4-0.
- 5) Finance:
 - a) Review and Approve Invoices Paid 8/1/2020-8/31/2020- Motion to approve by Wipperfurth, second by Madelung. Motion carried 4-0.
 - **b) Review and Approve Fund/Account Balances-** Motion to approve by Little, second by Madelung. Motion carried 4-0.
 - **c) Sinking Fund/Equipment Purchasing-** Motion to approve by Madelung, second by Little. Motion carried 4-0.
- 6) Chief LaFeber's Monthly Report/Action Items:

- a) Call Update- We had 126 calls for service compared to 120 in August last year. Turn out time was 2 minutes and 36 seconds, compared to last year's in August being 3 minutes and 4 seconds. A trend with calls being very slow for a while, and then getting really busy all at once. The department is looking at pushing a new recruitment class, and trying to get more paid on call volunteers to join who live in district. A new employee assistance program (EAP) was added on, for members to utilize their services such as counseling and personal legal consultation. A women's advocacy group was created with members, in order to help women and minorities receive equal opportunity. This is not a concern for the department, but more of a preventative action. Fire training is picking up, and there are several houses donated for the department to train on and burn. The new fire truck is looking to arrive late this fall. The department's ISO rating was 4-4 versus 4-5 last year (lower=better.) With the new truck coming in and the new training grounds, the rating should be even better next time.
- b) 2020 Budget Update- Budget is still looking good for the year. Chief LaFeber mentioned the need for a potential interim EMS officer. President Blau responded with some questions to have Chief answer next month at the meeting to plan this.
- c) State of Emergency Update- There is nothing new with this, other than Windsor having a new emergency plan. Wipperfurth asked if the fire district will still be in state of emergency and for how long. President Blau responded with explaining that it is more of a covid update. It was in agreement that the fire district was not in a state of emergency, and that Windsor lifted theirs about a month ago.

7) Old Business:

a) 2021 Budget- The department is still waiting for insurance numbers to come in. There was discussion on communicating with the contracted towns on the budget thus far, due to only minor changes left on numbers. Wipperfurth suggested to include them into the November meeting.

8) New Business:

- a) Strategic Plan- Chief LaFeber is still working on the development of the new strategic plan. The officers have come up with the top five areas of discussion for this plan, including: the second station, department leadership, training, employee health and wellness, and fiscal responsibilities and forecasting. The main focus and objective will be on the people.
- b) Second Station- There is a current need for more beds and sleeping quarters for members, having covid limit everyone to a separate room. Different ideas on how to add more space were discussed. An idea of a job trailer was brought up with portable sleeping quarters temporarily. Costs will be discussed at the next meeting. Chief LaFeber mentioned three potential options of land for a second station. There is also a building already standing with an efficient set up, that would be ready to purchase. There is potential to buy it and lease it back to the current tenant, which could boost revenue. Impact fees would not be able to be used for rent. There was discussion to talk about this further and more in depth, weighing out pros vs cons for the next meeting.
