**AN ORDINANCE AMENDING SECTION 2-225 IN THE WINDSOR CODE OF
ORDINANCES REGARDING THE EMERGENCY MANAGEMENT COMMITTEE**

WHEREAS, the Village Board found it prudent to create an Emergency Management Committee as an advisory and planning group to advise the Village Board on all matters pertaining to emergency preparedness and to provide for the establishment of operating procedures within an Emergency Management Plan; and

WHEREAS, the Village Board finds it necessary to amend the Emergency Management Committee to better serve the stated purposes.

NOW, THEREFORE, the Village Board of the Village of Windsor, Dane County, Wisconsin, do ordain as follows:


SECTION 1. Section 2-225 of the Code of Ordinances is hereby amended to read as stated in the attached Exhibit A.

SECTION 2. All other provisions of Code of Ordinances not specifically amended herein shall remain unmodified and in full force and effect.

SECTION 3. This ordinance shall take effect upon passage and publication as provided by law.

The above and foregoing Ordinance was duly adopted at a meeting of the Village Board of the Village of Windsor held on September 17, 2020, by a vote of 5 in favor and 0 opposed.

Sec. 2-225. - Emergency ~~management~~Management committeeCommittee.

- (a) *Composition.* The Emergency Management Committee shall consist of the following members:
- (1) Village President;
 - (2) ~~Chairperson of the Public Works Committee~~ One Village Trustee;
 - (3) Dane County Sheriff's Office—One Windsor Deputy;
 - (4) Fire Chief;
 - (5) One Citizen from the community;
 - (6) Village Clerk - Emergency Management Coordinator;
 - (7) Public Works Director;
 - (8) Village Administrator.
- (b) *Appointment.* The Village Trustee, Windsor deputy and citizen member shall be appointed by the Village President, confirmed by the Village Board and shall serve two year terms commencing on May 1 of each even numbered year. The ~~Chairperson of the Public Works Committee shall~~Village President will appoint a committee member to serve as chair of the Emergency Management Committee and the Emergency Management Coordinator (Coordinator) shall serve as Secretary of the Committee.
- (c) *Vacancies.* Whenever a vacancy shall occur, a member consistent with the composition of the committee shall be appointed by the Village President and confirmed by the Village Board to fill the unexpired term.
- (d) *Duties.* The Committee shall be an advisory and planning group and shall advise the Coordinator and the Village Board on all matters pertaining to emergency preparedness and shall provide for the establishment of operating procedures which will ensure the purposes herein set forth. The Committee shall meet ~~at two times during~~once every calendar year and at such additional times upon the call of the Chairperson.
