
**WHEREAS**, the Village Clerk has reviewed applications for Cigarette and Tobacco Products Retail Licenses and recommends **approval** of the following licenses:

- c. Windsor Travel Plaza


**NOW, THEREFORE, BE IT RESOLVED** by the Village Board of the Village of Windsor that all licenses referenced above are hereby approved.

<b>Issue Summary:</b>	<p>State Statutes require retail licenses for the sale of alcohol beverages and cigarettes to be approved and issued by local municipalities every year. The approved premise description represents where alcohol is authorized to be stored, sold, served and consumed. The premise is approved with the original application.</p> <p>Branch + Daughter has again applied for a Beer Garden Permit for the same premise as approved last year which included the grass lot in front of the building with 10 foot setbacks from the sidewalk/parking lot. Beer Garden Permits require annual approval.</p>
